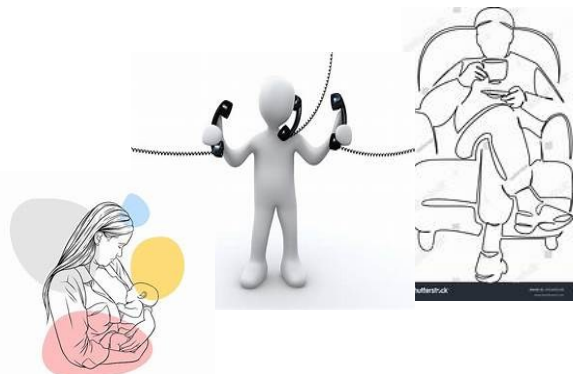

Adverse Pregnancy Outcomes and their Impact on Women's Health

Heart disease is the leading cause of death for women, with significant risks increasing in the years following pregnancy complications. Research shows that 80% of heart disease cases are preventable, and pregnancy itself acts as a stress test for a woman's body. This seminar will focus on the results from the Collaborative Perinatal Project and other population based studies that link certain pregnancy complications to higher risks of heart disease and diabetes, particularly within the first 10 years following childbirth.

Implementation of the Hospital Doula-Friendliness Guidebook: Building a Bridge Between Healthcare Providers and

Community-Based Doula *Allison Whitney, Nicole Jean Baptiste, Amaya Langaigine, Ashanda Saint Jean* **Governor A/B**

The panel will consist of 4 panelists including a doula, midwife, OB/GYN, and doula-supported client who either worked at or gave birth at an MHQIN doula-friendly hospital. The goal is to showcase the different perspectives of those involved in a patient's maternity care team at a hospital that has implemented the hospital doula-friendliness model. Speakers will begin with a brief introduction of the Hospital Doula-Friendliness Guidebook (each workshop attendee will receive a copy of the guidebook (will be referenced during session). Discussion will include a range of 5-7 questions that will address the following themes: implementation of a doula-friendly hospital policy, increasing staff and patient knowledge of doula support, integration of doulas into the maternity care team, and the overall benefits of having doula support within a hospital that is accepting of and inclusive of doulas.

Lose Dose, Big Benefits

Preeclampsia is defined as an elevated blood pressure after 20 weeks of pregnancy with clinical signs that one's brain, liver and kidneys are not functioning properly. It affects 1 out of 25 pregnancies and is a leading cause of maternal mortality. Black women are 60% more likely to have preeclampsia. Low dose aspirin is currently recommended for individuals at high-risk and moderate-risk for preeclampsia yet it is dramatically underutilized. This session will be a PowerPoint followed by a case study of a hospital that, after studying their patient population, implemented universal recommendation of low dose aspirin. This will be followed by a discussion and an opportunity for questions.

Mental Health without Borders: Social Work & Nursing Strategies for Supporting Migrant and Asylum-seeking Families

New York State Medicaid has established regional Social Care Networks (SCNs). The Social Care Networks are responsible for building a robust Network of Community-Based Organizations (CBOs) and other organizations providing health-related social needs services and coordinating with health care providers (inclusive of behavioral health and primary care providers). This session will share information on SCN's responsibility to ensure there is a seamless, consistent, coordinated, end-to-end process in their region for Screening, Navigation, and delivery of health-related social needs services. Social Care Network Lead Entities also engage a broader ecosystem of partners to achieve their goals, including health insurance plans, local government, and child & family supports. Attendees will learn what services are available through the SCNs and how to refer Medicaid members to them for services, and how your agency/program can participate in a social care network and be paid for services.

Intimate Partner Violence: An (Advanced) Guide to the understanding and Prevention of a “Third Rail” Issue from a Trauma-informed Perspective
